### **St. Charles Parish Sheriff's Dept. Overview / Sheriff Greg Champagne**

Sheriff Greg Champagne mentioned a recent event at Marathon, where the St. Charles Sheriff's Dept. Bomb Robot was used successfully to provide assistance.

Sheriff Champagne also spoke about some current issues being addressed by the National Sheriff's Association, including:

- The Presidential Election
- Illegal Immigration, Sanctuary Cities, and Border Security

### **Agency Reports**

#### **LA-SAFE (Kelli Polk)**

Kelly Polk was unable to attend, but submitted the following report through proxy:

- Since January there have been approximately thirty-five SARs, mostly access related and handled internally by security.
- Cyber- Devin King is back and now working with Louisiana State Police (LA-SAFE).
- There have been a number of reports of vandalized equipment at Pipeline Sites, along with several arrests for individuals conducting "sleeping dragon tactics".
- Lester mentioned two incidents involving suspicious UAS (Unmanned Aircraft Systems). The first involved a breach over the rail yard of an industrial facility in St. Charles Parish, and the second involved a drone launched by a mariner from a docked foreign flagged vessel.

#### **USCG Sector New Orleans (Bill Messer)**

- USCG Sector New Orleans is requesting recommendations from the Facility Security Officers on the best way to provide incident alert notifications through the USCG AWS System.
- Jim Polk, St. Charles Parish OHSEP, recommended notification to the St. Charles Parish EOC, which operates 24/7, and has constant radio contact with the facilities within St. Charles Parish.
- Mike Cisneros, Shell Motiva Norco (FSO), recommended notification directly to the 24/7 main facility control room number.

#### **FBI New Orleans Cyber Task Force (SA Matthew (Matt) Ramey)**

SA Matt Ramey introduced Himself, discussed the mission of the FBI N.O. Cyber Taskforce, and provided guidance on when and how to supply notification.
